EU-OSHA's high-level conference focuses on next steps for safety and health in MSEs

Managing occupational safety and health (OSH) can be a big challenge for micro and small enterprises (MSEs). What policies, programmes and tools are most effective to improve OSH in MSEs? And how can businesses be helped to make these work in practice? EU-OSHA, with policy makers and social partners, provided answers at a high-level conference in Brussels on 19 June, focusing on evidence-based recommendations from the most recent and wide-ranging MSE project reports.
